- Provide sign to voice and voice to sign interpreting.
- Work hourly, on a weekly schedule and are typically scheduled to support a student for an assigned class, lectures, laboratories, field trips, platform, and one to one or group discussions.

Butte College Interpreter Levels / Hourly Rate / Criteria

Levels	Hourly Rate	Criteria
1	\$27.00	In-house evaluation passed. EIPA Certification** (minimum overall score EIPA 3.0-secondary level) or Interpreter Training Program graduation and 1 year or more of professional interpreting experience.
2	\$32.00	In-house evaluation passed. EIPA Certification** (minimum overall score EIPA 3.5- secondary level) or Interpreter Training Program graduation and 2 years or more of professional interpreting experience.
3	\$37.00	In-house evaluation passed. EIPA Certification** (minimum overall score EIPA 4.0 written and performance-secondary level) or Interpreter Training Program graduation and 3 years or more of professional interpreting experience.
4	\$42.00	In-house evaluation passed. NAD / NIC / ACCI Generalist, RID CI Certification**, 5 years or more of professional interpreting experience.
5	\$47.00	In-house evaluation passed. NAD / NIC / ACCI Advanced, RID CT Certification**, 10 years or more of professional interpreting experience and an earned Bachelor's degree.
6	\$52.00	In-house evaluation passed. NAD / NIC / ACCI Master, RID CI & CT Certification**, 15 years or more of professional interpreting experience and an earned Master's degree or above.
