7.9 199 day work year contract (eleven or twelve months).

7.9.1 Upon recommendation of the Superintendent/President and approval of the Board of Trustees, non-classroom unit members may have a work year of 199 days (eleven months).

7.9.2 Upon recommendation of the Superintendent/President and approval of the Board of Trustees, unit members in the classifications of MESA Project Director, Distance Education and Accessible Learning Resources Coordinator, Learning Resource Specialists, and Professional Development Coordinator may have a work year of 199 days (twelve months).
