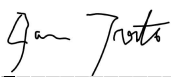
Existing Contract Language Article 13.10

13.10 All stipends granted under this contract will be adjusted by the cost of living percent granted to salary increases.

Amendment to Article 13.10

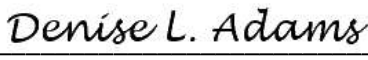
The parties agree to amend Article 13.10 to include the following language:

"This provision shall also apply to the Ancillary Rate. The ancillary rate shall be adjusted by the same cost of living percent increase applied to salary schedules and stipends."
