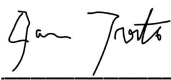


## MEMORANDUM OF UNDERSTANDING

The following memorializes the understanding of the Butte-Glenn Community College District (hereinafter referred to as the "District") and the Butte College Education Association (hereinafter referred to as "BCEA") regarding the additional stipend for the head coach for Volleyball.

For the spring 2026 semester, the head volleyball coach's stipend will be increased by \$4270.09 (33%), bringing the total annual stipend to \$17,209.75. This increase is being granted to cover the time and effort necessary to start the BC beach volleyball intercollegiate athletics team. The increase will be reevaluated upon completion of the coach duties time study that the District will conduct in spring 2026 and renegotiated as needed for future years.
