  - A. **New Course(s)**
    1. **ANTH 3 - Biological Anthropology Lab (1 Unit)**

Catalog Description: *This laboratory course is offered as a supplement to Introduction to Biological Anthropology either taken concurrently or in a subsequent term. Laboratory exercises are designed to introduce students to the scientific method and explore genetics, human variation, human and non-human primate anatomy and behavior, the primate/hominin fossil record and other resources to investigate processes that affect human evolution.*

    2. **ESL 305 - ESL Academic Reading and Writing (0 Units)**

Catalog Description: *This is a developmental reading and composition course designed to prepare advanced ESL students for the English composition requirement at the college level. English language learners develop their fluency in academic English with emphasis on reading, writing, and discussion skills. Unlimited repeats. Satisfactory/Unsatisfactory.*

**3. ETHS 3 - Ethnic Studies for Educators (3 Units)**

Catalog Description: *This course prepares current TK-12 educators and aspiring teachers to use the concepts and methods of Ethnic Studies in curriculum design (lesson and unit planning) and pedagogical practice in secondary education. Students will understand the history, value and core concepts of the Ethnic Studies discipline and will explore past and present experiences of historically marginalized students of color in the U.S. education system (focusing on Native American, African American, Asian American and Latina and Latino American communities). The course will cover historical inequalities that are reproduced within the U.S. education system as well as strategies for using education as a site for resistance, liberation and social justice.*

**4. MATH 30s - Analytic Geometry and Calculus I with Support (5 Units)**

Catalog Description: *A first course in differential and integral calculus of a single variable: functions, limits and continuity, techniques and applications of differentiation and integration, Fundamental Theorem of Calculus. Primarily for Science, Technology, Engineering & Math Majors. This course will contain the same curriculum as MATH 30 but will also have embedded support to review key pre-calculus concepts. This course emphasizes in-class activities and applications.*

Rationale: *The structure of the course is intended to be high touch where individual student needs are being assessed and met on a weekly basis.*

**B. Course Modification(s)**

**1. AGS 40 - Introduction to Animal Science**

Catalog Description: *A scientific approach to the livestock industry encompassing aspects of animal anatomy, physiology, nutrition, genetics and epidemiology. Emphasis on the origin, characteristics, adaptations and contributions of livestock to the modern agriculture industry. Laboratory exercises will provide an introduction to the empirical method including data collection and analysis. Field trips may be required. (C-ID AG-AS 104).*

Major Modification: Change in GE (CalGETC Area 5B), units (from 3 to 4), hours (from 34 lec/51 lab to 51 lec/51 lab), DE (remove Lecture), catalog description, objectives, unit titles, methods of instruction, methods of evaluation, and materials of instruction

2. **AJLE 164 - POST Dispatcher Course**

Catalog Description: *Becoming a public safety dispatcher means choosing dispatching not only as a career, but as an ethical commitment to maintain public trust. Public safety dispatchers must understand their role and responsibilities, understand the operation of the communications center, and act with a high degree of professionalism and ethics. This course will cover the communication process of dispatching, criminal justice system, laws and the California Penal Codes, communication technology operations, resource referral services, and wellness management. This course meets the minimum requirements for certification by the California Commission on Peace Officer Standards and Training. Pass/No Pass only.*

Major Modification: Change in units (from 6.5 to 8.5), hours (from 104 lec/16 lab to 146 lec/14 lab), catalog description, unit titles, methods of instruction, methods of evaluation, examples of assignment, and materials of instruction

Rationale: *The California Commission on Peace Officer Standards and Training (POST) has enhanced the existing Public Safety*

Effective Term: Summer 2024

3. **ANTH 2 - Introduction to Biological Anthropology**

Catalog Description: *This course introduces the concepts, methods of inquiry, and scientific explanations for biological evolution and their application to the human species. Issues and topics will include, but are not limited to, genetics, evolutionary theory, human variation and biocultural adaptations, comparative primate anatomy and behavior, and the fossil evidence for human evolution. The scientific method serves as the foundation of the course. (C-ID ANTH 110).*

Major Modification: Change in title (from "Physical Anthropology" to "Introduction to Biological Anthropology") catalog description, methods of instruction, methods of evaluation, examples of assignments, and materials of instruction

Rationale: *C-ID course alignment*

Effective Term: Fall 2025

4. **EDUC 110 - Critical Skills for College Success**

Catalog Description: *This course is designed to teach specific learning skills in general areas such as reading, writing, math, computer literacy, and study strategies. Requirements for the course include the student's participation in three conferences with Center for Academic Success (CAS) instructors; attendance at eight separate Critical Skills Workshops, each covering a different topic; and completion of homework for each workshop attended. Workshop topics are chosen specific to the individual needs of the student in support of a 100-level content class selected by the student. Pass/No Pass only. Open Entry/Open Exit.*

Major Modification: Change in CB08 (from NBS to BS), unit titles, examples of assignments, and materials of instruction

Rationale: *Curriculum review*

Effective Term: Fall 2025

5. **EMS 203 - Emergency Medical Technician Refresher**

Catalog Description: *This course meets the requirements for an individual to re-certify as a California State Emergency Medical Technician (EMT). Pass/No Pass only.*

Minor Modification: Change in prerequisite (from "EMS 111 and must possess a valid EMT Certificate in the State of California which is current or has been expired for no more than 24 months and a Healthcare Provider level CPR equivalent to the American Heart Association" to "Must possess a valid EMT Certificate in the State of California which is current or has expired for no more than 24 months and a Healthcare Provider level CPR equivalent to the American Heart Association"), methods of instruction, examples of assignments, and materials of instruction

Rationale: *Prerequisite change*

Effective Term: Fall 2024

6. **ESL 301 - ESL Level I**

Catalog Description: *This course provides a conversational approach to the learning of elementary English. It offers the English language learner practice in verbal communication with special emphasis on literacy and life skills. The introduction to basic literacy skills reinforces spoken and written English. Unlimited repeats. Satisfactory/Unsatisfactory only. Open Entry/Open Exit.*

Major Modification: Change in number and title (from "ESL 310 – Survival/Like Skills for ESL Students" to "ESL 301 – Level I"), levels below transfer (from 8 to 4), objectives, unit titles, methods of instruction, methods of evaluation, examples of assignments, and materials of instruction

Rationale: *Curriculum review*

Effective Term: Fall 2025

7. **ESL 302 – ESL Level II**

Catalog Description: *This course moves the English language learner from basic literacy skills to more in-depth practice with foundational grammatical structures and expressions in English. Speaking and listening skills are practiced, with introduction to writing and reading utilizing appropriate level texts. Unlimited repeats. Satisfactory/Unsatisfactory only. Open Entry/Open Exit.*

Major Modification: Change in number and title (from "ESL 311 – ESL Level 1" to "ESL 302 – ESL Level II"), enrollment (add "open entry/open exit"), levels below transfer (from 8 to 3), DE (remove), unit titles, methods of instruction, methods of evaluation, examples of assignments, and materials of instruction

Rationale: *Curriculum review*

Effective Term: Fall 2025

8. **ESL 303 - ESL Level III**

Catalog Description: *This course reinforces and expands an English language learner's literacy and communication skills for life, college, and career. It engages students in collaborative activities that integrate reading, writing, speaking, and listening. Intermediate grammar and vocabulary are introduced in context. Unlimited repeats. Satisfactory/Unsatisfactory only. Open Entry/Open Exit.*

Major Modification: Change in number and title (from "ESL 312 – ESL Level 2" to "ESL 303 – ESL Level III"), enrollment (add "open entry/open exit"), levels below transfer (from 7 to 2), DE (remove), objectives, unit titles, methods of instruction, methods of evaluation, examples of assignments, and materials of instruction

Rationale: *Curriculum review*

Effective Term: Fall 2025

9. **ESL 304 - ESL Level IV**

Catalog Description: *This course assists an English language learner in developing communication for life, career, and college. Through the integration of reading, writing, speaking and listening activities in English, this course prepares the student to communicate academically and introduces intermediate-to-advanced level grammar structures in context. Unlimited repeats. Satisfactory/Unsatisfactory only. Open Entry/Open Exit.*

Major Modification: Change in title from ("ESL 313 - ESL Level 3" to "ESL 304 - ESL Level IV"), enrollment (add "open entry/open exit"), levels below transfer (from 6 to 1), DE (remove), unit titles, methods of instruction, methods of evaluation, examples of assignments, and material of instruction

Rationale: *Curriculum review*

Effective Term: Fall 2025

10. **ESL 340 - Technology Skills for ESL Students**

Catalog Description: *This course will support English language learners as they acquire digital literacy practices to become users and creators of digital content. Students will use technology to engage in authentic English communication in a variety of personal, professional, and academic contexts. Students will engage in reading, writing, speaking, and listening strategies by exploring a variety of digital texts, genres, cultural artifacts, platforms, applications, and programs. Unlimited repeats.*

*Satisfactory/Unsatisfactory only.*

Major Modification: Change in enrollment (remove "open entry/open exit"), levels below transfer (from 6 to 1), hours (from 85 to 68), objectives, unit titles, methods of instruction, methods of evaluation, examples of assignments, and materials of instruction

Rationale: *Curriculum review*

Effective Term: Fall 2025

C. Discipline Change(s)

1. **ENGR 10 - Digital Logic Fundamentals**

Catalog Description: *In this course the student will be trained in the use of symbolic digital logic including switching algebra, optimization, Karnaugh map construction and use and the design of combinational logic networks. The student will develop skills in mapping of sequential logic theory to practical devices using flip-flops, registers and counters*

Discipline: Add Engineering Support

Rationale: *The department plans to add this course to a new Engineering Technician program*

Effective Term: Fall 2024

1. **EDUC 210 - Critical Skills for College Success**

Program Status: Standalone

Rationale: Course no longer offered

Effective Term: Fall 2024

E. New Program(s)

1. **AS Degree in Health Occupations Preparation (24-38 Units)**

Catalog Description: *An Associate in Science in Health Occupations Preparation degree readies students for programs such as licensed vocational nursing, registered nursing, and respiratory therapy at Butte College. This degree also prepares students to transfer to healthcare related programs at neighboring community colleges and/or four-year institutions to continue studies in their area of interest. Students should consult with a counselor for more information on varied requirements for specific pathways.*

Required Core: BIOL 20, BIOL 21, Select one: CHEM 1 or CHEM 51, Select one: MATH 18/18s or MATH 26/26s, Select one: ENGL 2 or ENGL 3; Select one option: LVN (3-4 units), RN/LVN-RN (16-17 units), or RT (13 units)

Effective Term: Fall 2024

F. Program Modification(s)

1. **AA-T Degree in Anthropology (19-21 Units)**

Catalog Description: *Students completing Associate Degrees for Transfer are guaranteed admission to the CSU system. Please see the beginning of the "Academic Programs" section for details. Anthropology is the study of humans worldwide, both in the past and present. The program is designed to introduce students to culture as the core concept for understanding human behavior. The four subfields of anthropology (physical, archaeological, linguistics and cultural) are used as a foundation to examine varied perspectives about the world. Anthropology students graduate with an awareness of cultural and biological diversity and the complexity of past and contemporary societies. The degree offers courses*

required in the CSU, Chico major core program, in addition to courses approved for CSU General Education.

Modification: Change in units (from 18-20 to 19-21), required core (add ANTH 3)

Effective Term: Fall 2025

2. **AA-T Degree in History (18 Units)**

Catalog Description: *Students completing Associate Degrees for Transfer are guaranteed admission to the CSU system. Please see the beginning of the "Academic Programs" section for details. History is the study of how the society we live in came to be. Through contemplation and analysis of historical materials, historians interpret the past and construct collective memory. The Associate Degree for Transfer in History supplies students with foundational knowledge in United States and World History, as well as with an introduction to the historical inquiry process. The degree offers three of five courses required in the CSU, Chico major core program, in addition to courses approved for CSU General Education.*

Modification: Change in List A: Select two (add HIST 21 and HIST 23); no change in units

Effective Term: Fall 2025

3. **Noncredit Certificate of Competency in ESL (0 Units)**

Catalog Description: *The Certificate of Competency in ESL is a sequence of noncredit ESL courses that takes English language learners from basic skills to high intermediate proficiency in preparation for their matriculation into credit courses. The program provides students with the foundational language proficiency for various career fields or to matriculate into General Education courses. This certificate program requires 110 hours of attendance over at least two academic semesters as well as the successful completion of at least two courses in the ESL sequence, one of which must be ESL 304.*

Modification: Change in program description, program learning outcomes, required core (from "ESL 313 - ESL Level 3" to "ESL 304 - ESL Level IV"), and require core choice select one (from "ESL 310, ESL 311, ESL 312, or ESL 340" to "ESL 301, ESL 302, ESL 303, or ESL 340")

Effective Term: Fall 2025

6. **Pending Item(s) – 6 minute(s)**

A. Course Modification(s)

1. **BCIS 16 - Project Management Tools**

Catalog Description: *This course introduces students to two industry-leading management software used in today's successful businesses: Microsoft (MS) Project and Outlook. Students will be introduced to Microsoft Outlook, a personal information management (PIM) software, that provides users with the integrated tools needed to manage professional e-mail communication and accounts; manage and organize events; and create and manage contacts, contact lists, and Groups. Students will also be introduced to Microsoft Project, a project management software, that provides users with the management tools needed to build and manage business plans/schedule including creating tasks; setting up resources; assigning resources; creating Gantt charts, and Timelines, and reports; and tracking progress.*

Minor Modification: Change in ped cap (30 to 24), methods of instruction, examples of assignments, and materials of instruction

Rationale: *The current ped cap is considerably higher than other programs running computer-based courses*

Effective Term: Fall 2025

2. **BCIS 18 - Introduction to Business Technology**

Catalog Description: *This course is an examination of information and communication technologies used in today's businesses and the impact these technologies are having on today's workplaces. The course will include examination and application of a wide range of information and communication technology tools used to support and enhance business functions and processes. Focus will be placed on solving a variety of business problems, improving organizational productivity, and achieving the goals of business.*

Minor Modification: Change in ped cap (30 to 24), and materials of assignments

Rationale: *The current ped cap is considerably higher than other programs running computer-based courses*

Effective Term: Fall 2025

3. **BCIS 20 - Beginning Keyboarding**

Catalog Description: *This course is designed for the student who has had little or no previous training in the operation of a keyboard. Students learn to type by touch, to use appropriate keyboarding techniques, and to develop speed and accuracy. Students learn to use common proofreader's marks in document editing.*

Major Modification: Change in ped cap (30 to 24), units (from 1.5 to 1.0), and materials of instruction

Rationale: *The current ped cap is considerably higher than other programs running computer-based courses; COCI unit compliance*

Effective Term: Fall 2025

4. **BCIS 24 - Advanced Keyboarding**

Catalog Description: *This course builds on basic keyboarding skills by reinforcing both proper keyboarding and effective speed building techniques in order for the student to reach an employable typing speed. Emphasis is placed on developing straight copy and production skills with minimum errors at increased speeds. Keyboarding strengths and weaknesses will be diagnosed, followed by prescriptive drills to address the issues. Topics include review of alphabet keystroke, word level, capital letter, alternate-hand, punctuation, number, symbol, and horizontal/vertical reaches.*

Major Modification: Change in ped cap (30 to 24), and units (from 1.5 to 1.0)

Rationale: *The current ped cap is considerably higher than other programs running computer-based courses; COCI unit compliance*

Effective Term: Fall 2025

5. **BCIS 28 - Microsoft Word for Windows**

Catalog Description: *This course covers a recent version of Microsoft Word for Windows for students who have an understanding of computers and desire comprehensive knowledge of word processing. Course content includes creating, editing, and formatting documents; creating and modifying headers and footers; inserting objects such as clipart, images, SmartArt, and WordArt; creating, modifying, and customizing tables; merging documents to create letters, envelopes and labels; creating charts; proofing documents; creating and managing shared documents and online forms; and automating process using macros. (C-ID BSOT 111X, BSOT 121X, BSOT 131X).*

Minor Modification: Change in ped cap (30 to 24), and materials of instruction

Rationale: *The current ped cap is considerably higher than other programs running computer-based courses*

Effective Term: Fall 2025

6. **BCIS 70 - Adobe Acrobat Professional**

Catalog Description: *This course introduces students to the current version of Acrobat Pro DC software's major features. Coverage includes interacting with PDFs using multiple devices, creating, scanning, converting, editing, sharing, signing, protecting, & standardizing PDFs. Additionally, ensuring accessibility, applying Bates numbering, redacting sensitive information, and preparing fillable forms will also be covered. (C-ID BSOT 125X).*

Minor Modification: Change in ped cap (28 to 24)

Rationale: *The current ped cap is considerably higher than other programs running computer-based courses*

Effective Term: Fall 2025

7. **BCIS 84 - Basics of Computers**

Catalog Description: *This course provides students who have limited personal computer experience with the basic technology skills needed to customize the Windows operating system user interface; manage files, folders, disks, and drives; operate basic Windows programs; and use basic search features of the Internet Explorer browser to locate information. The focus of this course is on preparing those students who are pursuing careers in business environments.*

Major Modification: Change in ped cap (25 to 24), and hours (from 12.50 lec/12.50 lab to 12.75 lec/12.75 lab)

Rationale: *The current ped cap is considerably higher than other programs running computer-based courses; COCI unit compliance*

Effective Term: Fall 2025

8. **BCIS 85 - Microsoft Excel for Windows**

Catalog Description: *This course covers a recent version of Microsoft Excel for Windows for students who have an understanding of computers and desire comprehensive knowledge of spreadsheets. Course content includes creating, formatting, and maintaining worksheets; using logical and financial formulas and functions; creating and modifying charts; using visual enhancements; working with tables and data tools; creating vlookup and hlookup reference functions; and creating pivot tables. (C-ID BSOT 112X, BSOT 122X, BSOT 132X).*

Minor Modification: Change in ped cap (30 to 24), and materials of instruction

Rationale: *The current ped cap is considerably higher than other programs running computer-based courses*

1. **MATH 10 - Finite Math for Liberal Arts (3 Units)**

Catalog Description: *This course is a survey of mathematical concepts in a variety of areas. Topics include linear functions, systems of linear equations and inequalities, matrices, linear programming, mathematics of finance, sets and Venn diagrams, combinatorial techniques and an introduction to probability. Applications in business, economics and social sciences.*

C-ID: MATH 130

Prerequisite: Intermediate Algebra or equivalent

Program Status: GE

2. **MUS 2 - Rap and Hip Hop Culture (3 Units)**

Catalog Description: *This course traces the social, historical, and cultural influences of rap and hip-hop as an artistic form and global cultural phenomenon. It is designed for students who wish to examine and explore hip-hop culture while developing background knowledge of hip-hop history. The course will explore hip-hop's global impact and how it has developed as an art form. Key performers, producers, and movement voices are highlighted. The connections between rap music and other elements of hip-hop culture will be explored and students will be challenged to think critically about rap music and its place in society. Various societal issues within rap and hip-hop will be thoroughly examined, including race, sexuality, class, authenticity, violence, gender, censorship, and politics.*

3. **MUS 8 - Music of Latin America and the Caribbean (3 Units)**

Catalog Description: *This course is an introduction to the musical traditions of Latin America, the Caribbean, and Latin music in the United States. Students will study music as a form of communication and as a social and cultural force. The course will focus on the rhythms, melodies, and cultural contexts of the music and will examine the role of music in social and political movements. Through lectures, discussions, and hands-on activities, students will gain a deeper understanding of the music's evolution, cultural significance, and its impact on the global stage.*

Different literature will be studied each semester. This course may be repeated 3 times to meet the requirements of the AA-T in Music.*

1. **AJ 1 - Criminology**

Catalog Description: *This course offers a comprehensive exploration of criminological theories and their application within diverse societal contexts, examining the interaction between law enforcement agencies and the communities they serve. Through a critical lens, students will explore the philosophy of law, the organizational structures of law enforcement at various governmental levels, and the dynamic interrelationships between these entities. Special emphasis is placed on the theoretical underpinnings of criminology, including biological, psychological, and sociological perspectives on crime and criminal behavior. The course critically addresses the influence of gender, sexuality, race, ethnicity, class, and culture on crime and criminal justice responses. Through an analysis of contemporary issues, historical developments, and comparative criminology, students are encouraged to apply theoretical concepts to understand the complexities of crime in a global context, fostering a deep appreciation for the contributions and perspectives of diverse groups. Graded only.*

2. **AJLE 151A - PC 832 Arrest Module**

Catalog Description: *This course is the first of two modules that comprise the minimum training standard for California peace officers as specified by the California Commission on Peace Officer Standards and Training (P.O.S.T.). Graduates of this course qualify for minimal peace officer powers as defined by the California Penal Code. This module contains instruction in 12 specific classroom subjects related to the authority and limitations of arrest. Additionally, students will participate in 10 hours of hands-on training in arrest, control, and searching techniques. Pass/No Pass only.*

4. **COS 10 - Health, Safety and Sanitation Theory**

Major Modification: Change in prerequisite (remove "Admission to the Cosmetology Program"), catalog description, objectives, unit titles, methods of instruction, examples of assignments, and materials of instruction

5. **COS 11 - Health, Safety and Sanitation Practicum**

Catalog Description: *This course will teach procedural application of standard health, safety, and sanitation practices in Cosmetology, Barbering, Manicuring, Hairstyling and Esthetics. Emphasis will be placed on the practice of Disinfection and Health standards required by the California State Board of Barbering and Cosmetology for practice and licensing in the beauty industry. Students will practice and demonstrate State Board disinfection and sanitation for beauty professionals while servicing the public. This course is designed toward preparation for the California Board of Barbering and Cosmetology exam.*

Major Modification: Change in hours (from 215 to 51), units (from 4 to 1), prerequisite (remove "Admission to the Cosmetology Program"), catalog description, objectives, unit titles, methods of evaluation, examples of assignments, and materials of instruction

6. **COS 12 - Manicuring and Pedicuring**

Catalog Description: *In this course students will develop and demonstrate proficiency in basic nail procedures. Topics are to include analyzation, treatment, creation, maintenance and removal of nail enhancements, including gel polish, wraps, repairs, acrylic and UV light cured gel enhancements. Students will work towards California State Board of Barbering and Cosmetology minimum practical hours and operations in subjects learned. This is a foundational course in the Cosmetology and Manicuring sequences.*

Major Modification: Change in hours (from 138 to 153), units (from 2.5 to 3), catalog description, objectives, unit titles, methods of instruction, methods of evaluation, examples of assignments, and materials of instruction

Rationale: *State mandated program hours*

**7. COS 17 - Trimming and Shaving I**

Catalog Description: *This fundamental course will introduce students to basic skills in beard trimming and shaving. Emphasis is placed on health and safety, Board of Barbering and Cosmetology standards, facial hair design, razor techniques, and equipment maintenance. Students will continue to work towards achieving the minimum hour requirements of California State Board of Barbering and Cosmetology practical operations in subjects learned.*

Major Modification: Change in hours (from 215 to 204), prerequisites (delete COS 19; add COS 10 and COS 11), catalog description, objectives, unit titles, methods of evaluation, and materials of instruction

Rationale: *State mandated program hours*

Effective Term: Fall 2025

**8. COS 19 - Hair Styling Services I**

Catalog Description: *In this course, students will develop and demonstrate fundamental hairstyling and haircutting skills. Emphasis is placed on State Board standards in client draping, shampooing and conditioning, fundamentals of hair design, and basic haircutting and basic hairstyling techniques. Students will practice and demonstrate State Board disinfection and sanitation techniques for beauty professionals while servicing the public. This course is designed toward preparation for the California State Board of Barbering and Cosmetology exam and is a fundamental course in the Cosmetology, Barbering or Hairstyling program sequences.*

Major Modification: Change in hours (from 215 to 204), catalog description, objectives, unit titles, methods of instruction, methods of evaluation, examples of assignments, and materials of instruction

Rationale: *State mandated program hours*

**9. COS 21 - Chemical Hair Services Practicum**

Catalog Description: *In this course students will develop and demonstrate understanding and practice of the basics of chemistry, chemical texture services, and the fundamentals of haircoloring. Students will work towards California State Board of Barbering and Cosmetology minimum practical operations in the subjects learned. This course is an integral class in the Barbering and Cosmetology program sequences.*

Major Modification: Change in hours (from 215 to 255), units (from 4 to 5), catalog description, unit titles, methods of instruction, methods of evaluation, examples of assignments, and materials of instruction

Rationale: *State mandated program hours*

Effective Term: Fall 2025

**10. COS 23 - Skin Care**

Catalog Description: *This course will develop the knowledge and skills necessary to understand the nature of skin care and show proficiency in skin-related services. Topics include skin disorders and diseases, skin structure, growth and nutrition, advanced skin care, facials and lashes, to include lash lifting, coloring and lash extensions. Students will work towards California State Board of Barbering and Cosmetology minimum requirements and hours in subjects learned. This course is part of the Cosmetology and Barbering sequences, and foundational in the Esthetics course sequence.*

Major Modification: Change in hours (from 215 to 204), catalog description, objectives, unit titles, methods of instruction, methods of evaluation, examples of assignments, and materials of instruction

**11. COS 27 - Trimming and Shaving II**

Catalog Description: *This course is the capstone course for the Barbering program. Students will practice and refine foundational practices, skills in beard trimming and shaving. Emphasis is placed on*

*health & safety, facial-hair design, razor techniques for advanced trimming and shaving. Students will continue to work towards achieving the requirements of California State Board of Barbering and Cosmetology practical operations in subjects learned.*

Major Modification: Change in hours (from 215 to 204), catalog description, unit titles, methods of instruction, methods of evaluation, examples of assignments, and materials of instruction

Rationale: *State mandated program hours*

#### **12. COS 29 - Hair Styling Services II**

Catalog Description: *In this course, students will expand and cultivate skills in haircutting and hairdressing. Topics will include client consultation, applying required health, safety and disinfection protocols, advanced haircutting techniques and formal hairstyling training. Students will work towards California State Board of Barbering and Cosmetology minimum hours in subjects learned. This course is an advanced course in the Cosmetology and Hairstyling program sequences.*

Major Modification: Change in hours (from 215 to 153), units (from 4 to 3), DE (Lec), catalog description, objectives, unit titles, methods of instruction, methods of evaluation, examples of assignments, and materials of instruction

#### **13. COS 32 - Advanced Manicuring and Pedicuring**

Catalog Description: *In this course students will perform advanced nail services on clients. Services include manicuring, pedicuring, safe use of manicuring equipment, nail enhancements and extensions, and safe removal of nail enhancements, acrylic, wraps and gel polish. Students will work towards California State Board of Barbering and Cosmetology practical operations and hours in subjects learned. This course is a capstone course in the Manicuring sequence.*

Major Modification: Change in hours (from 153 to 102), units (from 3 to 2), catalog description, unit titles, methods of instruction, methods of evaluation, examples of assignments, and materials of instruction

Rationale: *State mandated program hours*

#### **14. COS 39 - Advanced Hair Styling Services**

Catalog Description: *In this course, students will further expand and cultivate skills in haircutting and hairdressing. Topics will include client consultation, applying required health, safety and disinfection protocols, advanced haircutting techniques and formal hairstyling training. Students will work towards California State Board of Barbering and Cosmetology minimum hours in subjects learned. This course is an advanced course in the Cosmetology and Hairstyling program sequences.*

Major Modification: Change in hours (from 153 to 204), units (from 3 to 4), catalog description, unit titles, methods of instruction, methods of evaluation, examples of assignments, and materials of instruction

#### **15. MCGS 10 - Introduction to Women's Studies**

Catalog Description: *This course is designed to introduce students to women's studies as an interdisciplinary field of knowledge that explores critical questions about the meaning of gender in society. This course provides a foundational understanding of the experiences, contributions, and challenges faced by women throughout history and across cultures. By exploring key concepts, theories, and perspectives, students will gain insight into the complex issues surrounding gender, identity, and power dynamics in contemporary society. Women's studies strives to provide equal education to students by making the study of the history and culture of women and women's experiences, generally omitted*

*from the traditional curriculum, the central focus of scholarship. Topics may include law, culture, education, work, social policy, the media, and the family. (C-ID SJS 120).*

#### **16. MUS 4 - Song Writing**

Catalog Description: *This course is designed to teach students the basics of song writing with emphasis on the four primary elements required to write a good song: lyric development, chord progressions, melodic development, and song forms. Focus will be on creative songwriting by individuals and in teams, reflecting the trends in the modern music industry.*

Major Modification: Change in hours (from 17 lec/51 lab to 34 lec), DE (lec), discipline (add Commercial Music), ped cap (from 23 to 35), prerequisite (add MUS 3), objectives, unit titles, methods of instruction, methods of evaluation, examples of assignments, and materials of instruction

#### **17. MUS 51 - Digital Music Production I**

Catalog Description: *This course is an introduction to digital music production beginning with computer system operation and file management techniques. Students will apply practical concepts of modern music composition like programming drums, recording MIDI instruments, arranging and mixing, as well as post-production techniques including compression, equalization, reverb and other audio post effects.*

Major Modification: Change in hours (from 8.5 lec/76.5 lab to 34 lec/51 lab), units (from 2 to 3), catalog description, objectives, unit titles, methods of instruction, examples of assignments, and materials of instruction

Rationale: *Curriculum and program updates to meet student needs*

Effective Term: Fall 2025

#### **18. MUS 52 - Introduction to Recording Techniques**

Catalog Description: *In this course students will learn the fundamentals of studio recording techniques. Topics will include the history of recording technology, the fundamentals of sound, signal flow, microphone techniques, Digital Audio Workstations (DAWs), recording techniques, mixing consoles and typical studio gear. Students will gain hands-on experience with industry standard studio equipment in a professional quality recording studio.*

Major Modification: Change in hours (from 25.5 lec/76.5 lab to 34 lec/51 lab), unit titles, examples of assignments, and materials of instruction

Rationale: *Curriculum and program updates to meet student needs*

#### **19. MUS 53 - Digital Music Production II**

Catalog Description: *This course covers computer music production. The use of Digital Audio Workstations (DAWs) in composition and post-production are covered with hands-on project based learning, theory and demonstrations. Students will compose original music using software instruments and MIDI (Musical Instrument Digital Interface). Students will also study and complete audio post-production projects such as mixing a professional song, creating a radio commercial and creating a podcast.*

Major Modification: Change in hours (from 17 lec/102 lab to 34 lec/51 lab), unit titles, methods of instruction, methods of evaluation, examples of assignments, and materials of instruction

## 20. **MUS 54 - Studio Recording I**

Catalog Description: *This is a hands-on, project-based course in which students will apply learned methods and skills to Lab practice sessions and studio recording sessions. Students will set up and record using microphone technique, signal flow, gain staging and DAW recording, to create professional quality recordings. Students will learn proper microphone technique and post-production mixing techniques. The course will also cover how to copyright and publish music.*

Major Modification: Change in hours (from 17 lec/153 lab to 34 lec/51 lab), units (from 4 to 3), objectives, unit titles, examples of assignments, and materials of instruction

## 21. **MUS 55 - Studio Recording II**

Catalog Description: *This is a project-based course in which students will learn and apply advanced methods and skills to studio recording sessions and song production. The course includes concepts and techniques for advanced microphone technique and signal flow. Students will schedule, organize and produce recording sessions with musical artists and bands, and complete student recordings using advanced mixing techniques on analog consoles and Digital Audio Workstations (DAWs). Additional concepts will include studio etiquette, copyright, publishing and distribution of songs and albums.*

#### 2. **AA Degree in Music (30-32 Units)**

Catalog Description: *The Associate of Arts Degree in Music provides technical and artistic foundations to students interested in pursuing careers in music and music-related fields. The Associate of Arts Degree in Music is a forward-thinking degree that instructs students in performance, theory and composition, culture, technology, and business to prepare students for work in the modern music industry. In addition to courses in reading and writing music, students gain performance skills through instruction on an instrument or voice as well as through ensemble performance. Studies in the aesthetic and historical traditions of various musical cultures provide students with knowledge of the roles and functions of music in society. Students are introduced to the music industry and develop a working knowledge of*

music technology. This degree can also serve as preparation for additional musical studies or degrees for students wishing to transfer to a baccalaureate degree program as a music major.

**3. Certificate of Achievement in Music (21-22 Units)**

Students who complete the curriculum can seek entry-level employment as music educators, performers, music assistants, or other aspects of the music industry. Prior to beginning the coursework in this program, students should have at least some experience in reading printed music and playing an instrument/voice.*

Throughout the program, students will cultivate their music composition portfolios and enhance their resumes. The certificate encompasses intermediate skills in music theory, musicianship, jazz idioms, as well as foundational skills in arrangement, composition, and music in multimedia.*

#### 7. **AS Degree in STEM Foundations (31-42 Units)**

*Catalog Description: The AS degree in Cosmetology is a minimum 1,000-hour course of study designed to meet the State of California Cosmetology Act. Butte College offers a two-semester course of study to meet the curricular requirement mandated by the State Board of Barbering and Cosmetology that will enable a successful student to also earn a Certificate of Achievement, meet state licensing requirements for curricular training, result in 26 units of college credit and prepare students to pass the written state examination for licensure to practice cosmetology in the State of California.*

The student will be able to demonstrate hairstyling and haircutting skills, safety and sanitation, communication and soft skills, and knowledge necessary to pass*

*the State Board exam successfully. Upon completing the training, students will gain competency in entry-level job positions as a hairstylist or related career goals.*

**4. Certificate in Manicuring (9 Units)**

*Catalog Description: This certificate will prepare students to perform basic manipulative skills in manicures, pedicures, nail tips, wraps, and nail enhancements. The student will be able to demonstrate basic nail care skills, safety and sanitation, communication and soft skills, and knowledge necessary to pass the State Board exam successfully. Upon completing the training, students will gain competency in entry-level job positions as a Manicurist or related career goals.*

**5. AA-T Degree in Music (21-22 Units)**

*Catalog Description: Students completing Associate Degrees for Transfer are guaranteed admission to the CSU system. Please see the beginning of the "Academic Programs" section for details. The Associate of Arts Degree in Music for Transfer prepares students to demonstrate transfer-level proficiency in solo and ensemble performance as well as music theory and musicianship for a seamless transfer into a baccalaureate degree program as a music major. This degree is recommended for students pursuing careers in music and music-related fields. Completion of this curriculum will demonstrate commitment to the serious study of music in practice and in theory, and provide comprehensive preparation for upper-division work. The Butte College Music Department provides the highest level of instruction for students to pursue their musical and educational goals. The faculty have devised a curriculum that serves to develop skills in musical performance as well as academic preparation for continued study and lifelong learning.*

**6. AS Degree in Recording Arts (24 Units)**

Courses include theory, performance, digital music production, and hands-on experience including recording, overdubbing, mixing and mastering. The program prepares students for a host of careers within and beyond the recording studio, including but not limited to Assistant Engineer, Assistant Mix Engineer, Studio Booking Technician, Audio/Visual Technician, Studio Owner, Information Technology Specialist and Customer Service Representative, Video Game Audio Engineer, and TV and Film Audio Engineer.*
