### **Program Description**

The A.S. in Electrician Training is an approved training program by the California Division of Labor Standards. Students enrolled in this program can obtain their Electrician Trainee card in order to seek employment with a C-10 contractor and earn their required on-the-job hours. The program will prepare Students to pass the State Electrical Examination and Certification process. Students in this program will acquire skills in the principles of electricity, circuitry, and power distribution, electrical construction processes, and safety codes.

How does the program align with the College Mission Statement, District Educational Plan, and Strategic Plan?

This program very easily aligns with the College's Mission Statement by offering a high quality education and support in a career pathway. According to the Bureau of Labor Statistics 21% of the electricians in the US are Hispanic, this program will compliment our status as an HSI. An Electrical Program would also align very well to our Strategic Initiative number 5, Modeling Sustainability. With our Region, State, and Country moving away from fossil fuel energy to a much cleaner electric energy policy. The process of converting to all or mostly electrical systems is going to create a very large demand for trained electricians.

Explain how the program is appropriate to the Community College mission of providing the first two years of a baccalaureate degree?

This is a career education program, it does not currently align with a 4-year degree.

How does the proposal demonstrate need for the program?

Butte College has been contacted by the construction sector, specifically electrical contractors to start an electrical program. The only program in the entire North State CA Jobs First region is at Shasta Builders Exchange. The Far North Center for Excellence labor market report prepared in January of 2024 states "Community colleges and other postsecondary training providers issued zero awards over the last three years" for electrical training certificates. Since the 2018 Camp Fire destroyed the town of Paradise, there has been a shortage of construction workers in Butte County. Industry need is strong, with a minimum need of 30-45 in Butte County alone. The Far North Center for Excellence provided a labor market report that states that the projected job growth for electricians in the North/Far North Region to have a 10% growth in the years 2022-2027 with 369 new annual openings per year. This report does not take into account the effects of the passage of the Federal Inflation Reduction Act which contains provisions for mass electrification of U.S. households.

Annual Completers: How many students do you anticipate completing this program each year?

Each cohort will have 20 students, and when the program grows, we will offer a Fall and Spring start. If there is demand we will also be able to offer courses in the evening to accommodate those with a job.

What are the impacts on existing programs (enrollment, staffing, section offerings)?

There should be no impact on existing programs other than some opportunities for staffing crossover and potential course cross listing within other programs.
