Course Description: This course is an introduction to the conservation and management of natural resources. Students will learn about the diverse agencies that manage our resources along with their history and philosophies. The major natural resources including water, air, energy, forests, wildlife, agriculture, and soils will be covered and students will learn about the environmental policy and laws that govern use of these resources. An emphasis is placed on the practical components of Environmental Science as it relates to social and economic aspects of conservation.

Objectives

Upon successful completion of this course, the student should be able to:

1. Describe and apply the basic elements of the scientific method to problems in the field.
2. Distinguish among the various types of natural resources and how they are used.
3. Evaluate the effects of our human population upon the earth's resources.
4. Assess the various reasons for protecting and maintaining biodiversity.
5. Evaluate different management practices used to maintain forest ecosystems and wildlife resources.
6. Evaluate the various resource agencies and their management philosophies.
7. Assess the role of parks, national forests, and wilderness play in our society.
8. Distinguish among the various causes of soil erosion.
9. Evaluate and discuss the sources of air and water pollution along with some of the solutions to those problems.
10. Investigate how alternative energy sources can be used to meet future demand.
11. Evaluate environmental policies and their effectiveness in resources conservation.
